- 1.2. The Parties intend to create a joint venture companies for owning and managing projects on the territory of the Russian Federation in the following areas:
- 1.2.1 production, breeding and sale of small cattle based on Romanov breed and Iranian original breed for improving the meat's quality. Party 2 is responsible for the presence of territory and breeding breed of sheep. Party 1 is responsible for technology and breeding Iranian sheep.
- 1.2.2. production, breeding, and sale of cattle and development genetic center with the use of Iranian genetic material on the territory of the Russian Federation in the Yaroslavl and Moscow, Samara regions. Party 1 is responsible for genetic material, technology, specialists. Party 2 is responsible for the territory and the farm.
- 1.2.3. acquisition and management of land plots for the cultivation of grain on it in the Russian Federation, as well as the creation of infrastructure for the production of dry feed with subsequent export to Iran
- 1.3. The Parties intend to establish a joint venture company for the ownership and management of projects on the territory of Iran in the following areas:
- 1.3.1 industrial projects for the cultivation of agricultural products in greenhouses with subsequent export to the Russian Federation
- 1.3.2 industrial projects for the cultivation and processing of seeds in special mountain areas

1.4. Party 1 confirms its intention to supply through Party 2:

- hatching eggs
- spermodosis
- heifers .
- embryos
- heifers
- 1.5. Party 2 confirms its intention to supply to

- 3. The Memorandum has been drawn up and signed by the Parties in two copies, each of which has the force of the original.
